# MESSAGE FROM THE PRESIDENT

Another successful year for the Delta Community Foundation has now come and gone. In 2022/2023, through the generosity of community members and partners, the DCF was able to distribute over \$90,000 to charities and non-profits in Delta.

This past year community partners, such as Evolution Fulfillment, Ape Ship Courier and Freight, and the City of Delta enabled the DCF to host two successful warehouse sales that generated approximately \$60,000 to support the Delta Community Foundation.

The big event for the Delta Community Foundation in 2023 was the Give from the Heart gala, which was held on February 11 at the Cascades Casino in Delta. This was the DCF's first gala and was tremendously successful both from a fundraising and a brand awareness perspective. When all the bills were paid, the gala netted over \$70,000.

We were pleased to support a variety of smaller charities and programs in 2022/2023 that included Spuds in Tubs, the Take a Hike Alternate Education Program, Sher Vancouver's Friendship Program, Youth Mental Health peer support groups and the Starfish Pack program. The contributions to these charities help make Delta a better place to live for its citizens and are in addition to several scholarships and bursaries that the DCF awards each year to students of the Delta School District.

The Kindness Meter program continued to raise dollars in 2022/2023, which were used to support emergent needs such as Extreme Weather and Food Insecurity programs.

In 2024, the Delta Community Foundation hopes to build on the successes of the past year; increase awareness of the funding opportunities that DCF offers; and, of course, continue to build the funds that the DCF manages. In 2024 our aim is to continue to grow our assets and therefore our ability to support smaller charities in Delta.

The varied experience and expertise manifested in our Board of Directors make these goals possible. I would like to personally thank all of our individual donors, corporate donors, volunteers and DCF board members: Without your help, the DCF could not have the impact in Delta that we have had historically, and will continue to have into the future.



# 2023 IS A GOOD YEAR TO CONSIDER A GIFT OF SECURITIES

Currently, donors who gift appreciated securities receive a full Donation Tax Credit and do not have to pay any Capital Gains Tax. This has significantly reduced the actual cost of the donation, and has had a very positive impact on the total amount given to our charities.

This is about to change on January 1, 2024.

The Government of Canada has proposed a change to the Alternative Minimum Tax (AMT) that will significantly reduce the benefits to donors with incomes over \$173,000, and who plan to give securities now or in their estate.

The basic premise is to reduce the donors Donation Tax Credit by 50%, and to disallow 30% of their Capital Gains Exemption in the AMT calculation. If the AMT changes are not retracted, or deferred, tax advisors are suggesting that potential donors of securities consult their own tax professional and consider <u>making their gift of securities in 2023</u>.

The charitable sector has opposed these changes, but the outcome is uncertain.
